## Resolution enacting and rescinding traffic regulations on various streets.

RESOLVED, That, in accordance with the provisions of the California Vehicle Code and the San Francisco Traffic Code, the following regulations governing the movement of vehicles are hereby enacted or rescinded as designated below:

## RIGHT TURN ONLY AFTER BALLPARK EVENTS EXCEPT TAXIS - RESCIND NO RIGHT TURN AFTER BALLPARK EVENTS EXCEPT TAXIS - ESTABLISH

Southbound Hawes, Ingalls, and Jennings Streets at Ingerson Avenue

# NO LEFT TURN, TAXIS EXEMPT, EXCEPT 4 PM TO 7 PM, MONDAY THROUGH FRIDAY – RESCIND NO LEFT TURN, EXCEPT BUSES AND TAXIS – ESTABLISH

Mission Street, westbound, at 1<sup>st</sup>, 4<sup>th</sup> and 10<sup>th</sup> Streets: and

Mission Street, eastbound, at Fremont, 2<sup>nd</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, 6<sup>th</sup> and 7<sup>th</sup> Streets.

Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street.
