Resolution Urging the Mayor to Release Funding for the Department of Public

[Resolution Urging the Mayor to release funds to the Department of Public Health]

WHEREAS, The Mayor's Office restricted funding in the Department of Public Health's budget in FY 04-05 in order to generate General Fund savings after the defeat of Proposition J (1/4% sales tax) and Proposition K (temporary 1/10th of 1% gross receipts business taxes); and,

WHEREAS, Some of these restricted funds were targeted to providing direct heath care services to chronically ill San Franciscans; and,

WHEREAS, The reduction to the budget of the Department of Public Health resulted in de-funding 11.0 full time equivalent Public Health Nurses, 6.8 full time equivalent Senior Medical Social Workers, and one full time equivalent Health Care Billing Clerk; and,

WHEREAS, The funds to support these positions were moved into a contingency reserve that is unavailable to the Department of Public Health; and,

WHEREAS, The positions that were de-funded are responsible for providing critical health, social service and billing services for chronically ill patients of San Francisco; and,

WHEREAS, The de-funded positions resulted in the elimination of the only citywide program that provides skilled nurses and nursing care for at home patients; and,

WHEREAS, The elimination of the program resulted in a loss for elderly, disabled and terminally ill patients to have their long term health care needs met; and that the Board of Supervisors wishes to reinstate; now therefore, be it

RESOLVED, That the Board of Supervisors urges the Mayor to release the funding needed to allow the Department of Public Health to fund the positions and to reinstate the aforementioned public health services to the community; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges the Mayor to prioritize long term chronic health care for at home patients in fiscal year 2005-2006.
