**Resolution urging the Department of Parking and Traffic to establish a blue zone in front of St. Aidan's Church.**

WHEREAS, St. Aidan's opens its doors to all members of the community as the host yoga classes, pain mediation classes, AA and Alanon meetings, and has initiated a program to provide space for performance groups so that audiences of up to 200 see arts, dance, and musical entertainment in the church sanctuary, and

WHEREAS, St. Aidan's Church provides Community Ministries Grants comprising of 10% of Church income each year to nonprofits including the Night Ministry, Safehouse, Vista Del Monte, Sojourn and the SF Food Bank; and

WHEREAS, St. Aidan's runs an after school tutoring program, called Aidan's Way, for neighborhood children that live in affordable housing that has grown to an enrollment of 24 students; and

WHEREAS, St. Aidan's Church is inclusive in all aspects of its work, including raising over \$700,000 to make the church accessible to the entire community including the installation of accessible bathrooms, a wheelchair lift from the first level to the church level and a ramp from the sidewalk to the first level; and

WHEREAS, St. Aidan's Church wants to make it as easy as possible for people with disabilities to attend public events at the church; and

WHEREAS, St. Aidan's Church believed that as part of its structural upgrade that a blue zone was approved on Diamond Heights Boulevard, to enable access from the street to the ramp and wheelchair ramp; and

1           WHEREAS, St. Aidan's Church was later denied the blue zone after all construction  
2 was completed; now, therefore be it

3           RESOLVED, That the San Francisco Board of Supervisors urges the Department of  
4 Parking and Traffic to install a blue zone on Diamond Heights Boulevard in front of St. Aidan's  
5 Church.


