[Accept-Expend Federal Grant – 2005 After-School Snack Pilot Program]

Resolution authorizing the Department of Children, Youth and Their Families to accept and expend a grant in the amount of \$196,453 from the United States Department of Agriculture for the 2005 After-School Snack Pilot Program.

WHEREAS, Approximately 35,000 children in San Francisco are eligible for the free and reduced school lunch program; and,

WHEREAS, Hunger impairs a child's ability to learn, grow and stay healthy, and is associated with increased behavior problems including hyperactivity and aggression; and,

WHEREAS, The United States Department of Agriculture has created a pilot Year-Round Feeding Program to provide reimbursement funding for sponsors to offer after-school snacks for children; and,

WHEREAS, Funding from the pilot Year-Round Feeding Program will enable the City and County of San Francisco's After-School Snack Program to provide children with free snacks through 25 after-school program sites by the end of its first year of operation, providing an average of 1,250 children per day with a nutritious snack during the after-school hours; and,

WHEREAS, The Budget Analyst report prepared for the February 24, 2005 Budget & Finance Committee hearing on childhood nutrition programs listed the pilot Year-Round Feeding Program as an example of an additional federal funding source the City and County of San Francisco should be drawing upon to fund food programs for children; and,

WHEREAS, The grant terms prohibit indirect costs; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it

Supervisor Maxwell BOARD OF SUPERVISORS FURTHER RESOLVED, That the City and County of San Francisco hereby authorizes the Department of Children, Youth, & Their Families to apply for, accept and expend funds in the amount of \$196,453 from the United States Department of Agriculture to sponsor the 2005 After-School Snack Pilot Program.
