5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the  
6 following intersections are hereby designated as "STOP" intersections, and the Department of  
7 Parking and Traffic is hereby authorized and directed to cause "STOP" signs to be installed  
8 thereat as designated below:

8 **STOP SIGNS - ESTABLISH**

9 Faxon Avenue, Elmwood Way and Southwood Drive, making this uncontrolled five-  
10 legged intersection an All-Way STOP;

11 Kansas Street at Vermont/22nd Street, making this uncontrolled intersection an All-  
12 Way STOP;

13 Persia Avenue and London Street, stopping Persia Avenue at London Street making  
14 this intersection an All-Way STOP; and,

15 17th Street and Alabama Street, stopping 17th Street at Alabama Street, making this  
16 intersection an all-way STOP.

17 1(c)(9) changes in the traffic and parking regulations  
18 where such changes do not establish a higher speed  
19 limit or result in more than a negligible increase in the  
20 use of the street.




