Resolution urging the 109<sup>th</sup> Congress to pass S 910 and HR 1849, the Breast Cancer Patient Protection Act of 2005, requiring a post-mastectomy hospital stay to be determined by the patient and her doctor, not an insurance company.

WHEREAS, Breast cancer is the most common cancer among women and about 211,000 women are estimated to be diagnosed with invasive breast cancer in 2005; and

WHEREAS, One in every seven women will be diagnosed with invasive breast cancer in her lifetime; and,

WHEREAS, Deaths from breast cancer are decreasing because of early detection and improved treatment; and,

WHEREAS, Health insurance organizations in many states are not required to consult with a patient's doctor when determining the approved length of hospitalization following mastectomy or lymph node dissection; and,

WHEREAS, Laws in at least 18 states, including California, allow breast cancer patients and their doctors to determine the length of their stay, thereby protecting patients from insurance companies that would otherwise force them to leave the hospital too soon; and

WHEREAS, The American Medical Association supports the fundamental concept that medical decisions should be made by patients and their physicians, rather than by insurers; and

WHEREAS, S910 and HR 1849 would require health insurance companies to provide at least 48 hours of hospital stay in connection with a mastectomy or breast conserving surgery and at least a 24 hour stay in connection with a lymph node dissection unless the
