3 **Resolution extending the prescribed time within which the Planning Commission may**  
4 **render its decision on a proposed ordinance to amend the Planning Code with respect**  
5 **to controls in the North Beach Neighborhood Commercial District.**

7 WHEREAS, On March 15, 2005, the Board of Supervisors initiated the process to  
8 amend the Planning Code when the Honorable Aaron Peskin introduced a proposed  
9 ordinance with respect to various controls in the North Beach Neighborhood Commercial  
10 District, a copy of which is on file with the Clerk of the Board of Supervisors in File No.  
11 050433; and,

12 WHEREAS, On March 22, 2005, the Clerk of the Board referred the proposed  
13 ordinance to the Planning Commission; and,

14 WHEREAS, On June 16, 2005, the Planning Commission conducted a duly noticed  
15 hearing on the proposed ordinance, but continued the matter and requested additional time to  
16 review the proposed ordinance; and,

17 WHEREAS, The Board, in accordance with Planning Code section 306.4(d), may  
18 extend the prescribed time within which the Planning Commission is to render its decision on  
19 proposed amendments to the Planning Code that the Board of Supervisors initiates; and,

20 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning  
21 Commission an extension of 30 days to review the proposed ordinance and render its  
22 decision; now, therefore, be it

23 RESOLVED, That by this resolution, the Board hereby extends for 30 days the  
24 prescribed time within which the Planning Commission may render its decision on the

1 proposed ordinance with respect to controls in the North Beach Neighborhood Commercial  
2 District.
