4 **terms ending June 6, 2007, to the Immigrant Rights Commission.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated persons to serve as members of the  
8 Immigrant Rights Commission, pursuant to the provisions of Ordinance No. 211-97, for the  
9 term specified:

10 Deborah Escobedo, succeeding herself, seat 4, term expired, must have a  
11 demonstrated knowledge of and interest in the health, human service, educational, or  
12 employment issues that affect immigrants residing in San Francisco, for the unexpired portion  
13 of a two-year term ending June 6, 2007.

14 Felix Levy, succeeding Richard Ow, seat 6, term expired, must be an immigrant to the  
15 United States who is appointed in accordance with Section 4.101 of the Charter. In addition,  
16 members shall have a demonstrated knowledge of and interest in the health, human service,  
17 educational, or employment issues that affect immigrants residing in San Francisco, for the  
18 unexpired portion of a two-year term ending June 6, 2007.

19 Samira Causevic McCoy, succeeding Phu Nguyen, seat 8, term expired, must be an  
20 immigrant to the United States who is appointed in accordance with Section 4.101 of the  
21 Charter. In addition, members shall have a demonstrated knowledge of and interest in the  
22 health, human service, educational, or employment issues that affect immigrants residing in  
23 San Francisco, for the unexpired portion of a two-year term ending June 6, 2007.
