3 **Resolution approving the award of Contract Proposal No. 350 (Procurement of**
4 **Standard Low Floor Hybrid-Electric Diesel Coaches) between the City and County of**
5 **San Francisco and Orion Bus Industries, in an amount not to exceed \$29,398,629.**

7 WHEREAS, The Municipal Railway's Clean Air Plan entitled "Zero Emissions 2020"
8 calls for the adoption of new hybrid buses to replace 56 of its oldest 40-foot diesel buses; and

9 WHEREAS, On March 15, 2005, the Board of Supervisors adopted Resolution No.
10 205-05, which supports immediate action to implement the Municipal Railway's Clean Air
11 Plan, including expediting procurement of hybrid electric buses by 2007; and

12 WHEREAS, On September 7, 2004, the Municipal Transportation Agency Board of
13 Directors ("MTA Board") adopted Resolution No. 04-133, which authorized the Director of
14 Transportation to conduct a negotiated procurement after receipt of proposals for Contract No.
15 350 (Procurement of Standard Low Floor Hybrid-Electric Diesel Coaches); and

16 WHEREAS, On November 24, 2004, Muni received five proposals from three bidders,
17 of which Muni determined that two proposals from one bidder and one proposal from another
18 bidder were responsive and in the competitive range; and

19 WHEREAS, After negotiations with the two proposers, and receipt of best and final
20 offers ("BAFOs"), Muni's Technical Evaluation Subcommittee evaluated the BAFOs on
21 technical content, past performance, and ability to deliver the buses in conformity with the
22 City's preferred delivery schedule; Muni's Price Evaluation Subcommittee independently
23 scored the price proposals; and the technical and price scores were then combined; and

24 WHEREAS, The proposal from Orion Bus Industries received the highest combined
25 score by the Evaluation Committee; and




