10 WHEREAS, Paul Xavier, Douglas Cox and David C. Kapp are seeking transfer of
11 a Type 48 on-sale general public premises license for DECO Lounge located at 510
12 Larkin Street from 1312 Polk Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED, That in accordance with Section 23958.4 of the California Business**
18 **and Professions Code, the Board of Supervisors of the City and County of San**
19 **Francisco hereby determines for the foregoing reasons that the transfer of a Type 48**
20 **on-sale general public premises license from 1312 Polk Street to 510 Larkin Street for**
21 **Paul Xavier, Douglas Cox and David C. Kapp for DECO Lounge, will serve the public**
22 **convenience and necessity of the people of the City and County of San Francisco.**

23 Conditions: (1) No noise shall be audible beyond the area under control of the
24 licensee; (2) Petitioners shall not permit their patrons or the general public to loiter or
25 congregate on the sidewalks adjacent to the licensed premises; (3) The petitioner(s)

1 shall be responsible for maintaining free of litter the area adjacent to the premises over
2 which they have control; (4) Sales and service of alcoholic beverages shall be permitted
3 only between the hours of 9:00 a.m. and 2:00 a.m.; (5) No off-sale privileges.


