

1 [Authorizing the Committee on Information Technology and the Purchaser to amend the
2 Contract with Ciber, Inc. for computer-related services from an amount not to exceed
\$9,999,999 to an amount not to exceed \$25,000,000.]

3 **Resolution authorizing the Committee on Information Technology and Purchaser to**
4 **amend the contract between Ciber, Inc. and the City and County of San Francisco for**
5 **computer-related services by increasing the amount of the contract from an amount**
6 **not to exceed \$9,999,999 to an amount not to exceed \$25,000,000.**

8 WHEREAS, The Committee on Information Technology and the Office of Contract
9 Administration issued a request for proposal in April 2002 (the "RFP") for contractors for the
10 City's Computer Store; and

11 WHEREAS, The Computer Store consists of a pool of vendors under contract with the
12 City to provide computer hardware and software related services; and

13 WHEREAS, Ciber, Inc., is one of eight vendors who were awarded a contract pursuant
14 to the RFP; and

15 WHEREAS, The contract with Ciber, Inc. (the "Contract") is for an amount not to
16 exceed \$9,999,999; and

17 WHEREAS, The Contract has a term of three years, commencing January 1, 2004 and
18 expiring December 31, 2006, with two separate options to extend the term, each for an
19 additional year; and

20 WHEREAS, The contract has been amended twice--by the First Amendment, dated
21 January 1, 2005, to authorize advance payments for hardware maintenance and software
22 support services; and by the Second Amendment dated February 11, 2005, to authorized
23 other public agencies to procure services from Ciber, Inc.; and

1 WHEREAS, A copy of the Contract, including each amendment is on file with the Clerk
2 of the Board of Supervisors in File No. 050645, which is hereby declared to be a
3 part of this Resolution as if set forth fully herein; and

4 WHEREAS, The Committee on Information Technology and the Office of Contract
5 Administration estimate that expenditure under the Contract could exceed the contract's not-
6 to-exceed amount of \$9,999,999 in the reasonably near future and approach approximately
7 \$40,000,000 over the term of the Contract; now, therefore, be it

8 RESOLVED, That the Board of Supervisors authorizes the Committee on Information
9 Technology and the Purchaser, or her designee, to amend the contract with Ciber, Inc., dated
10 January 1, 2004, for computer-related services by increasing the amount of the contract from
11 an amount not to exceed \$9,999,999 to an amount not to exceed \$25,000,000.




