Conditions: (1) No noise shall be audible beyond the area under control of the licensee; (2) Petitioners shall not permit their patrols or the general public to loiter or congregate on the sidewalks adjacent to the licensed premises. Patrons standing in line to enter the premises shall not be considered loitering or unlawfully gathering; (3) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to

the premises over which they have control; (4) No alcoholic beverages shall be consumed on any property adjacent to the premises over which the licensee has control; (5) The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
