8 WHEREAS, The Transportation Fund for Clean Air (TFCA) Regional Funds program  
9 provides funding to projects that reduce air pollution from motor vehicles as set forth in  
10 California Health and Safety Code Sections 44241 and 44242; and,

11 WHEREAS, The Bay Area Air Quality Management District (BAAQMD) is authorized to  
12 make funds available from the TFCA Regional Funds Program to eligible projects; and,

13 WHEREAS, The Municipal Transportation Agency (MTA) is an eligible recipient for  
14 assistance under the TFCA Regional Funds Program; and,

15 WHEREAS, The MTA has applied for \$876,050 in TFCA Regional Funds to purchase  
16 and install particulate matter traps on diesel motor coaches, establish bicycle lanes, and  
17 facilitate traffic calming through restriping; now, therefore, be it;

18 RESOLVED, That the Board of Supervisors authorizes the MTA to accept and expend  
19 \$876,050 in TFCA Regional Funds to purchase and install particulate matter traps on diesel  
20 motor coaches, establish bicycle lanes, and facilitate traffic calming through restriping; and, be
