

1 [Appointment – Local Homeless Coordinating Board]

3 **Resolution appointing Christine Ma, M.D., for a term to be determined, to the Local**
4 **Homeless Coordinating Board, residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated person to serve as a member of the Local
8 Homeless Coordinating Board, pursuant to the provisions of Resolution Nos. 827-97, 926-99,
9 729-01 and 208-05, for a term to be determined:

10 Christine Ma, M.D., (residency waiver required), new appointment, seat 9, must be a
11 representative of homeless or formerly homeless, community advocacy organizations,
12 service-provider agencies, business and corporate sectors or the foundation community, for a
13 term to be determined; and be it

14 FURTHER RESOLVED, that the Board of Supervisors makes the following findings:

- 15 1. The membership of the Local Homeless Coordination Board has a goal to be
16 representative of the diversity of the City and County of San Francisco.
- 17 2. Applicant Christine Ma, M.D., a new appointee, who is not a resident of San
18 Francisco, is a person with experience that uniquely qualifies her to serve on the
19 Local Homeless Coordinating Board.
- 20 3. The Local Homeless Coordinating Board has attempted to fill the position, for
21 which Christine Ma M.D., was nominated, with an individual who is a City
22 resident and who has the specific experience, skills, and qualifications, but has
23 been unable to do so at this time. The Rules Committee has certified that
24 Christine Ma, M.D., is qualified to serve on the Local Homeless Coordinating
25 Board.
4. After exercising due diligence, the Board of Supervisors concludes that there is
no other possible representative, who is a resident of San Francisco and who
has the specific experience, skills, or qualifications possessed by this applicant,

1 and who is willing to serve on the Local Homeless Coordinating Board at this
2 time, and, be it

3 FURTHER RESOLVED, that the Board of Supervisors waives the residency
4 requirement for Christine Ma, M.D., as allowed in cases where no qualified City
5 resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter
6 that requires person(s) appointed to boards, commissions, and advisory bodies
7 established by legislative act of the Board of Supervisors to be resident(s) of the City
8 and County of San Francisco.




