4 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
5 **accept and expend retroactively a continuation grant from the Substance Abuse Mental**
6 **Health Services Administration (SAMHSA) in the amount of \$200,000 for the**
7 **YouthPOWER Project; for the period of October 1, 2005, to September 30, 2007.**

9 WHEREAS, SFDPH applied for and was awarded a continuation grant in the amount of
10 \$200,000 from the Substance Abuse Mental Health Services Administration (SAMHSA) for
11 the YouthPOWER project for the period of October 1, 2005 to September 30, 2007; and,

12 WHEREAS, Funding for the YouthPOWER Project was originally authorized by the
13 Board of Supervisors under Resolution No. 844-02; and,

14 WHEREAS, The funding for this project was accepted as a continuation grant from the
15 original funder, the US Department of Justice, Office of Juvenile Justice Programs for the
16 period of October 1, 2003, through September 30, 2005, and,

17 WHEREAS, The new funder for this grant is the Substance Abuse Mental Health
18 Services Administration (SAMHSA); and,

19 WHEREAS, The SFDPH has requested from the Board of Supervisors a change in this
20 funding from the US Department of Justice, Office of Juvenile Justice Programs (OJJJ) to the
21 Substance Abuse Mental Health Services Administration (SAMHSA); and,

22 WHEREAS, The grant budget includes provision for indirect costs of \$31,733; and

23 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
24 may be placed automatically on consent agendas in committee, as they are usually

1 considered to be routine items, and this resolution authorizes the acceptance and expenditure
2 of grant funding; now, therefore, be it


3 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a
4 grant in the amount of \$200,000 from a new fund administrator, SAMHSA; and, be it

5 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
6 grant funds in accordance with the requirements set forth in the original Agreement pursuant
7 to San Francisco Administrative Code section 10-170-1; and, be it

8 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
9 agreement on behalf of the City; and, be it


10 FURTHER RESOLVED, That the Controller is directed to designate the position funded


