3 **Resolution authorizing the Juvenile Probation Department to accept and expend a**
4 **grant in the amount of \$50,000 from the Zellerbach Family Foundation to support**
5 **organizational development activities at the Juvenile Probation Department and to fund**
6 **technical assistance for planning for such organizational change.**

8 WHEREAS, The Zellerbach Family Foundation has made available funding for
9 organizational development activities and technical assistance benefiting the Juvenile
10 Probation Department of the City and County of San Francisco; and

11 WHEREAS, Due to the need for organizational development, the Juvenile Probation
12 Department will seek and develop in-service training curricula, sponsor management
13 meetings and retreats, and facilitate parent, youth advisory group development; and,

14 WHEREAS, The Juvenile Probation Department will use funds to obtain technical
15 assistance to help design a strategic plan that will support a long-term partnership between
16 the Juvenile Probation Department and the Zellerbach Family Foundation with the goal of
17 producing comprehensive organizational change within the Juvenile Probation Department
18 over time; and

19 WHEREAS, the Juvenile Probation Department has been selected to receive an
20 unconditional, unrestricted grant in the amount of \$50,000 from the Zellerbach Family
21 Foundation; now, therefore, be it

22 RESOLVED, That the Juvenile Probation Department of the City and County of San
23 Francisco is authorized to enter into the attached grant award agreement on behalf of the
24 City; and, be it

1 FURTHER RESOLVED, That William P. Siffermann, Chief Probation Officer of the San
2 Francisco Juvenile Probation Department is authorized to accept and expend \$50,000 of the
3 grant funds for the benefit of the San Francisco Juvenile Probation Department; and, be it

4 FURTHER RESOLVED, That the City and County of San Francisco will adhere to the
5 requirements of the Zellerbach Family Foundation and all conditions specified in the grant
6 agreement.


