3 **Resolution enacting and rescinding parking regulations at various locations.**  
4

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the parking of  
7 vehicles are hereby enacted or rescinded as designated below:

8 **RESIDENTIAL PERMIT PARKING AREA "W" (2-HOUR TIME LIMIT, 8 AM TO 6 PM,**  
9 **MONDAY THROUGH FRIDAY) - ESTABLISH**

10 Rhode Island Street, both sides, from the 1100 block of Rhode Island to 22nd Street  
11 (1000 block); and,

12 Bryant Street, both sides, between 21st and 22nd Streets (2300 block).

13 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM TO 6 PM,**  
14 **MONDAY THROUGH FRIDAY) - ESTABLISH**

15 Lincoln Avenue, south side, between 7th and 8th Avenues (600 block).

16 **RESIDENTIAL PERMIT PARKING AREA "S" (2-HOUR TIME LIMIT, 8 AM TO 9 PM,**  
17 **MONDAY THROUGH FRIDAY) - ESTABLISH**

18 Divisadero Street, west side, between Haight and Waller Streets (200 block, odd  
19 numbers).

20 **RESIDENTIAL PERMIT PARKING AREA "Z" (2-HOUR TIME LIMIT, 8 AM TO 6 PM,**  
21 **MONDAY THROUGH FRIDAY) - ESTABLISH**

22 Church Street, both sides, between Cesar Chavez and 27th Streets (portion of the  
23 1400 block).

24 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

25 Geary Street, south side, from the Powell Street intersection to 138 feet easterly.

**TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

1 South Van Ness Avenue, west side, from 60 to 100 feet north of Cesar Chavez Street.

2 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

3 Harriet Street, west side, from 245 feet to 292 feet north of Bryant Street (A 47-foot  
4 zone accommodating 12 unmetered motorcycle spaces).

5 **TOW-AWAY, NO PARKING, 8 PM TO 4 AM, FRIDAY NIGHT THROUGH SUNDAY**  
6 **MORNING - ESTABLISH**

7 Broadway, both sides, between Columbus Avenue and Montgomery Street.

8 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND**

9 Howard Street, north side, between Main and Beale Streets.

10 **TOW-AWAY, NO STOPPING, 7 AM TO 9 AM, AND 4 PM TO 6 PM, MONDAY THROUGH**  
11 **FRIDAY - RESCIND**

12 Howard Street, north side, from Beale Street to 200 feet westerly.

13 **BUS STOP, TOW-AWAY, NO PARKING, 6 AM TO 10 AM, MONDAY THROUGH FRIDAY -**  
14 **ESTABLISH**

15 Howard Street, south side, from Spear Street to 90 feet easterly.

16 **TOW-AWAY, NO STOPPING, 7 AM TO 9 AM, AND 4 PM TO 6 PM, MONDAY THROUGH**  
17 **FRIDAY - RESCIND**

18 Howard Street, north side, from Beale Street to 200 feet westerly.

19 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

20 Holyoke Street, west side, between Woolsey Street and Karen Court.

21 **TOW-AWAY, NO PARKING ANYTIME - RESCIND**

22 Guerrero Street, east side, from 21st Street to 60 feet northerly.

23 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

24 10th Avenue, east side, between the driveways of 1365 and 1371 10th Avenue  
25 (accommodating 2 unmetered motorcycle spaces).

unmetered motorcycle spaces).


