5 WHEREAS, In 1979, Joe Goode began synthesizing a genre of dance theater that  
6 combined text, gestures, and humor with his own deeply physical, high velocity dancing; and,

7 WHEREAS, In 1986 the Joe Goode Performance Group incorporated as a non-profit  
8 organization; and,

9 WHEREAS, The Joe Goode Performance Group's mission is to make an intimate art  
10 that illuminates the human story as a way of fostering compassion and tolerance, and to  
11 enrich and promote the art form of interdisciplinary dance theater; and,

12 WHEREAS, The Joe Goode Performance Group has been recognized nationally and  
13 internationally, winning prizes including a New York Bessie and a San Francisco Izzie; and,

14 WHEREAS, The Joe Goode Performance Group is known for their innovation and  
15 leadership in the field and have been acknowledged by the National Endowment for the Arts,  
16 the California Arts Council, the American Council on the Arts, and the California Dance  
17 Educators Association; and,

18 WHEREAS, The Joe Goode Performance Group's mission also includes educating  
19 people about the power of art making through workshops and seminars, and Joe Goode has  
20 taught thousands of San Francisco and Bay Area dancers over the last two decades; and

21 WHEREAS, On June 2nd, the Joe Goode Performance Group will premiere *Stay*  
22 *Together*, the first commissioned work for dance composed by San Francisco Symphony  
23 music director, Michael Tilson Thomas, representing a unique collaboration between two San  
24 Francisco arts icons now, therefore be it




