10 WHEREAS, Emil Maionchi is seeking issuance of a Type 42 on-sale beer and
11 wine public premises license for Wine Merchant of Showplace Square, located at 2
12 Henry Adams Street, Space M-21; and,

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42
20 on-sale beer and wine public premises license, to Emil Maionchi dba Wine Merchant of
21 Showplace Square, located at 2 Henry Adams Street, Space M-21 will serve the public
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: 1) On-sale consumption of alcoholic beverages shall be permitted
24 between the hours of 6:00 p.m. and 8:00 p.m. each day of the week. 2) Petitioners
25 shall not permit their patrons or the general public to loiter or congregate on the

1 sidewalks adjacent to the licensed premises. 3) The petitioner(s) shall be responsible
2 for maintaining free of litter the area adjacent to the premises over which they have
3 control. 4) Individual servings of alcoholic beverages shall not exceed six-ounce pours
4 for beer or four-ounce pours for wine.




