3 **Resolution accepting and expending (1) a gift to the Fire Department of \$100,000 from**
4 **the Fireman's Fund Insurance Company for the Department's Neighborhood**
5 **Emergency Response Training ("NERT") Program and (2) gifts to the Fire Department**
6 **from Johnson & Johnson of \$100,000 for the NERT Program and of medical supplies**
7 **valued at \$20,000 for the NERT Program or for disaster relief.**

9 WHEREAS, The Fireman's Fund Insurance Company was founded in San Francisco in
10 1863 with a mission to give a portion of its profits to support firefighters and has established
11 the Fireman's Fund Heritage program to support the company's philanthropic mission to
12 support firefighters for safer communities by funding equipment, tools, firefighter training, fire
13 safety education and community emergency response programs; and,

14 WHEREAS, the Heritage Program has offered to provide the Fire Department with a
15 gift of \$100,000 for the NERT program; and,

16 WHEREAS, Johnson & Johnson provided major disaster relief support during the 1906
17 Earthquake and Fire and has always felt a special kinship with San Francisco Firefighters and
18 City residents, and on the occasion of the 100th anniversary of the 1906 Earthquake and Fire
19 proudly offered to support the Fire Department's efforts to educate and train the public to be
20 prepared for a future emergency; and

21 WHEREAS, Johnson & Johnson has offered to provide the Fire Department with a gift
22 of \$100,000 for the NERT program and an in-kind donation of medical supplies valued at
23 \$20,000 to be used in the NERT training programs or for disaster relief; and

24 WHEREAS, these gifts will benefit the Fire Department and facilitate its safe and
25 effective delivery of services and training to the public; now, therefore, be it

1 RESOLVED, That the Chief of the Fire Department is authorized to accept and expend
2 gifts of \$100,000 from Fireman's Fund Insurance Company and \$100,000 from Johnson &
3 Johnson to support the NERT program, and to accept a gift from Johnson & Johnson of
4 medical supplies valued at \$20,000, to be used for the NERT program or for disaster relief.




