3 **Resolution concurring with the Controller's certification that services previously**  
4 **approved under Proposition J can be performed by private contractor for a lower cost**  
5 **than similar work performed by City and County employees, for the following services:**  
6 **youth programs (Juvenile Probation).**

7 WHEREAS, The Electorate of the City and County of San Francisco passed  
8 Proposition J in November 1976, allowing City and County Departments to contract with  
9 private companies for specific services which can be performed for a lower cost than similar  
10 work by City and County employees (Charter Section 10.104.15); and,

11 WHEREAS, The Board of Supervisors has previously approved outside contracts  
12 under Proposition J for the services listed below; and,

13 WHEREAS, The Controller has determined that an award of a contract for the services  
14 listed below to a private contractor will continue to achieve substantial cost savings for the  
15 City; and,

16 WHEREAS, The Controller's certification, which confirms that said services can be  
17 performed at lower costs to the City and County by private contractor than by employees of  
18 the City and County, is on file with the Clerk of the Board of Supervisors in File  
19 No. 060894, which is hereby declared to be part of this resolution as if set forth fully  
20 herein; now, therefore be it;

21 RESOLVED, That the Board of Supervisors hereby concurs with the Controller's  
22 certification and approves the Proposition J Resolution concerning the Purchaser's award of a  
23 contract to a private contractor for the services listed below for the period of July 1, 2006  
24 through June 30, 2007.
