4 **Resolution authorizing the Director of Public Health and the Director of the Office of**

10 WHEREAS, The Department of Public Health desires to provide health, dental and
11 vision insurance to San Francisco children, who are ineligible for other publicly funded health
12 insurance programs, and who live in families with incomes under 300% of the federal poverty
13 guidelines; and,

14 WHEREAS, The amount of said contract will exceed ten million dollars (\$10,000,000);


16 WHEREAS, Section 9.118 of the San Francisco Charter requires that such contracts
17 be approved by the Board of Supervisors; now, therefore, be it

18 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public
19 Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the
20 City and County of San Francisco, to contract with the San Francisco Community Health
21 Authority (commonly referred to as the San Francisco Health Plan) for the period July 1, 2006
22 through June 20, 2007 to provide universal health insurance services for San Francisco
23 children and young adults aged 0 through 24 and young parents aged 19 through 24; and, be


