7 WHEREAS, It is the goal of the San Francisco Department on the Status of Women to  
8 achieve a seamless citywide response to domestic violence; and,

9 WHEREAS, Since 2001, DOSW has been working collaboratively towards this goal  
10 with the City's public safety and criminal justice agencies, including Adult Probation, District  
11 Attorney, Emergency Communications, Police, and Sheriff; and,

12 WHEREAS, Through the Justice and Courage Project, DOSW and its partner agencies  
13 have identified that training for criminal justice personnel is a critical part of successfully  
14 addressing domestic violence; and,

15 WHEREAS, The Blue Shield of California Foundation is the largest private funder of  
16 domestic violence programs in California and has awarded a grant to DOSW to provide  
17 domestic violence training for first response criminal justice personnel; and,

18 WHEREAS, DOSW will use the funds to design and implement a Domestic Violence  
19 Training Institute for 500 personnel over the next two years; and,

20 WHEREAS, The grant budget includes provision for indirect costs of \$25,000; now,  
21 therefore, be it


22 RESOLVED, That the Board of Supervisors hereby authorizes the Executive Director
