9 WHEREAS, The United States Congress has tasked the Department of Homeland
10 Security (DHS) to conduct a pilot program to new concepts of operation in air cargo explosive
11 detection screening; and,

12 WHEREAS, DHS has contracted with the University of California Lawrence Livermore
13 National Laboratory to conduct the air cargo explosive detection system pilot programs; and,

14 WHEREAS, San Francisco International Airport has been chosen as one of the three
15 participating airports; and,

16 WHEREAS, Lawrence Livermore National Laboratory has determined that the most
17 efficient means of designing and building the project is for the Airport to provide project
18 management, professional services and construction for the pilot program pursuant to a
19 Reimbursement Agreement with Lawrence Livermore National Laboratory; and,

20 WHEREAS, The estimated total amount of the Agreement is \$10,000,000.00
21 representing full reimbursement by Lawrence Livermore National Laboratory of all Airport
22 costs; and,

23 WHEREAS, It is in the best interest of all users of SFO that cargo packages undergo
24 explosive detection screening prior to placement on passenger airlines; now, therefore, be it


