3 **Resolution authorizing the Department of the District Attorney of the City and County**  
4 **of San Francisco to retroactively accept and expend a grant in the amount of \$25,000**  
5 **from the Metta Fund Health Foundation for a program entitled “Back on Track” for**  
6 **fiscal year 2006/2007.**

8 WHEREAS, The City and County of San Francisco desires to establish a certain  
9 project designated the Back on Track Program to be funded in part from funds made available  
10 from the Metta Fund Health Foundation (hereafter “Metta”); and,

11 WHEREAS, The terms of the grant provide that 10% of the grant funds be limited to  
12 administrative overhead costs; now, therefore, be it

13 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of  
14 the City and County of San Francisco to retroactively accept and expend funds from Metta for  
15 the purposes of its Back on Track Program; and, be it

16 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
17 indirect costs in the grant budget; and be it

18 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of  
19 the City and County of San Francisco the necessary Grant Award Agreements for Back on  
20 Track Program purposes, including any extensions, augmentations or amendments thereof;  
21 and be it

22 FURTHER RESOLVED, That the District Attorney is authorized and empowered to  
23 execute, deliver and perform, in the name of the City and County of San Francisco, all  
24 applications, contracts, agreements, amendments and payment requests necessary for the



7 be it


8 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
