

1 [Accept-expend State Grant Funds available under the Department of Homeland Security,  
2 Federal Emergency Management Agency for Fiscal Year 2005 Pre-disaster Mitigation Grant  
3 Program to fund the Moscone Recreation Center Project]

4 **Resolution authorizing the San Francisco Recreation and Parks Department to accept**  
5 **and expend a grant in the amount of \$2,067,176 in FY 2005 Pre-Disaster Mitigation**  
6 **Funds from the Federal Emergency Management Agency, administered by the**  
7 **California Office of Emergency Services, for seismic improvements to the Moscone**  
8 **Recreation Center Pre-Disaster Mitigation Project.**

10 WHEREAS, Federal Emergency Management Agency (FEMA) through its designated  
11 agent, the Governor's Office of Emergency Services of the State of California (Cal OES), may  
12 provide funds to support the federal Pre-Disaster Mitigation Grant Program, authorized under  
13 the §203 Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§  
14 5121-5206 (Stafford Act); and

15 WHEREAS, Cal OES has reviewed projects including the Moscone Recreation Center  
16 Pre-Disaster Mitigation Project for compliance with federal and state rules and regulations as  
17 promulgated by FEMA; and

18 WHEREAS, FEMA, through its agent Cal OES, has advised that \$2,067,176 in FEMA  
19 Pre-Disaster Mitigation Competitive Program Funding has been awarded for the Moscone  
20 Recreation Center Pre-Disaster Mitigation Project as proposed by the San Francisco  
21 Recreation and Parks Department (SFRPD) and the grant Project shown above within the  
22 State, setting up necessary procedures; and,

23 WHEREAS, SFRPD proposed Moscone Recreation Center Pre-Disaster Mitigation  
24 Project will implement a seismic upgrade that includes: 1) new concrete footings along with  
25 perimeter shear walls; 2) new hold downs along all shear walls; 3) new plywood sheathing

1 along all shear walls; 4) doubles studs at all edges of all walls and wall opening; 5) 6x8 and  
2 4x6 collector chords along all shears walls; and, 6) new 1/2" plywood roof sheathing across  
3 entire roof; and

4 WHEREAS, The SFRPD proposes to maximize use of the available grant funds on  
5 program expenditures by not including indirect costs in the grant budget;

6 now, therefore, be it

7 RESOLVED, That the City and County of San Francisco hereby approves the  
8 acceptance and expenditure of federal assistance in the amount of \$2,067,176 for the  
9 Moscone Recreation Center Pre-Disaster Mitigation Project from the Pre-disaster Mitigation  
10 Competitive Program under the Department of Homeland Security, Federal Emergency  
11 Management Agency, and, be it

12 FURTHER RESOLVED, That the City and County of San Francisco waives inclusion of  
13 indirect costs in the grant budget; and, be it


14 FURTHER RESOLVED, That the City and County of San Francisco certifies that  
15 Grantee has reviewed, understands and agrees to the General Provisions contained in the  
16 Contract; and, be it

17 FURTHER RESOLVED, That the City and County of San Francisco appoints the  
18 General Manager of the Recreation & Parks Department and the Capital Program Manager of  
19 the Recreation and Parks Department as agents to conduct all negotiations, execute and  
20 submit all documents including, but not limited to applications, agreements, payment requests  
21 and so on, which may be necessary for the completion of the aforementioned project.




