15 this day, helping in the dining room and the garden, and at the age of 95 is still volunteering at
16 the Senior Center, primarily helping with the recycling from the center's offices; and

17 WHEREAS, Margarita Hernandez has always brought an unbelievable energy to the
18 Senior Center, whether through her dancing or her great sense of humor; now, therefore, be it
