1 [Accept and Expend State grants.]

3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **retroactively accept and expend a five new grants totaling \$11,122.63, four from the**  
5 **California Department of Food and Agriculture (CDFA) and one from the California**  
6 **Department of Pesticide Regulation (CDPR); for the period of July 1, 2006 through June**  
7 **30, 2007.**

9 WHEREAS, SFDPH has applied for and been awarded four grants from the CDFA,  
10 including Egg Quality Control (\$2,256.18), Pest Exclusion (\$5,550.45), California Organics –  
11 Organic Foods Act (\$1,000), Seed Service and Nursery Stock Inspection Program (\$500) and  
12 one from the CDPR, Pesticide Use Reporting (\$1,816); and,

13 WHEREAS, As a condition of receiving the grant funds, the CDFA and CDPR require  
14 the City to comply with the terms of five agreements (the "Agreements"), copies of which are  
15 on file with the Clerk of the Board of Supervisors in File No. 061473, which is  
16 hereby declared to be a part of this resolution as if set forth fully herein; and,

17 WHEREAS, The grant terms prohibit including indirect costs in the grant budget for all  
18 but one grant, the Pest Exclusion Grant; now, therefore, be it


19 RESOLVED, That SFDPH is hereby authorized to retroactively accept and expend five  
20 grants in the total amount of \$11,122.63 from the CDFA and CDPR; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
22 indirect costs in the budget of the four Agreements, where prohibited; and, be it


23 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
24 Agreements on behalf of the City.


