8 WHEREAS, The Zellerbach Family Foundation has made funding available to support
9 organizational development activities and technical assistance benefiting the Juvenile
10 Probation Department of the City and County of San Francisco; and

11 WHEREAS, Due to the Juvenile Probation Department's need for organizational
12 change and development, the adoption of evidence based practices designed to improve
13 interactions with youth that will inspire successful outcomes, and restored partnerships with
14 system stakeholders; and,

15 WHEREAS, The Juvenile Probation Department will use funds from the Zellerbach
16 Family Foundation to design and promote comprehensive organizational change, introduce
17 and implement evidence based practices to reduce recidivism, and restore effective
18 partnerships with system stakeholders and community-based organizations over time; and

19 WHEREAS, the Juvenile Probation Department has been selected to receive an
20 unconditional, unrestricted grant in the amount of \$600,000 from the Zellerbach Family
21 Foundation; now, therefore, be it

22 RESOLVED, That the Juvenile Probation Department of the City and County of San
23 Francisco is authorized to enter into the attached grant award agreement on behalf of the
24 City; and, be it


