3 **Resolution appointing Suresh Patel, Dipak Patel, Seth Katzman, Christina Olague and**
4 **Wai Ching Kwan to the SRO Task Force, terms ending December 31, 2009, residency**
5 **requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the SRO
9 Task Force, pursuant to the provisions of Resolution 459-06, for the terms specified:

10 Suresh Patel, new appointment, seat 2, must be a private SRO owner/operator, for a
11 three-year term ending December 31, 2009.

12 Dipak Patel, new appointment, seat 3, must be a private SRO owner/operator, for a
13 three-year term ending December 31, 2009.

14 Seth Katzman, new appointment, seat 4, must be a non-profit SRO owner/operator, for
15 a three-year term ending December 31, 2009.

16 Christina Olague, new appointment, seat 5, must be a representative of the Mission
17 SRO Collaborative, for a three-year term ending December 31, 2009.

18 Wai Ching Kwan, new appointment, seat 7, must be a representative of the Chinatown
19 SRO Collaborative, for a three-year term ending December 31, 2009; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 21 1. The membership of the SRO Task Force has a goal to be representative of the diversity of
22 the City and County of San Francisco.
- 23 2. Applicant Wai Ching Kwan, a new appointee, who is not a resident of San Francisco, is a
24 person with experience that uniquely qualifies him to serve on the SRO Task Force.

- 1 3. The SRO Task Force has attempted to fill the position, for which Wai Ching Kwan was
2 nominated, with an individual who is a City resident and who has the specific experience,
3 skills, and qualifications, but has been unable to do so at this time. The Rules Committee
4 has certified that Wai Ching Kwan is qualified to serve on the SRO Task Force.
- 5 4. After exercising due diligence, the Board of Supervisors concludes that there is no other
6 possible representative, who is a resident of San Francisco and who has the specific
7 experience, skills, or qualifications possessed by this applicant, and who is willing to serve
8 on the SRO Task Force at this time; and, be it

9 FURTHER RESOLVED, That the Board of Supervisors waives the residency
10 requirement for Wai Ching Kwan, as allowed in cases where no qualified City resident, willing
11 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
12 appointed to boards, commissions, and advisory bodies established by legislative act of the
13 Board of Supervisors to be resident(s) of the City and County of San Francisco.
