3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine**
4 **public premises license to Kumi Walker and Sean Heywood, for MR. located at**
5 **560 Sacramento Street, Suite 100, will serve the public convenience and**
6 **necessity of the people of the City and County of San Francisco, in accordance**
7 **with Section 23958.4 of the California Business and Professions Code, with**
8 **conditions.**

10 WHEREAS, Kumi Walker and Sean Heywood are seeking issuance of Type 42
11 on-sale beer and wine public premises license for MR., located at 560 Sacramento
12 Street, Suite 100; and,

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42
20 on-sale beer and wine public premises license, to Kumi Walker and Sean Heywood for
21 MR., located at 560 Sacramento Street, Suite 100, will serve the public convenience
22 and necessity of the people of the City and County of San Francisco.

23 Conditions: (1) The sale, service, and consumption of alcoholic beverages shall
24 be permitted only between the hours of 8:00 a.m. and 10:00 p.m. each day of the week.
25 (2) No "happy hour" type of reduced price alcoholic beverage promotion shall be

1 allowed. (3) There shall be no coin operated games or video machines maintained
2 upon the premises at any time. (4) No noise shall be audible beyond the area under
3 control of the licensee(s) as defined on the ABC-257 dated November 7, 2006. (5) At
4 no time shall any person under the age of 21 years enter or remain in this public
5 premises. (6) No person under the age of 21 years of age shall sell, furnish, or deliver
6 alcoholic beverages. (7) Loitering (loitering is defined as "to stand idly about; linger
7 aimlessly without lawful business") is prohibited on any sidewalks or property adjacent
8 to the licensed premises under the control of the licensee as depicted on the ABC-257,
9 dated November 7, 2006. (8) The petitioner(s) shall be responsible for maintaining free
10 of litter the area adjacent to the premises over which they have control. (9) Petitioner
11 shall not make structural changes in the premises interior without prior written approval
12 from the Department. (10) The sale of alcoholic beverages for consumption off the
13 premises is strictly prohibited.


