Resolution supporting San Francisco's Unified School District's efforts to purchase and implement a Point of Sale system to improve the Student Nutrition Services meal programs.

WHEREAS, The San Francisco Unified School District's (SFUSD) Department of Student Nutrition Service (SNS) provides breakfast, lunch and snacks for up to 56,000 students in the San Francisco public school system each day; and

WHEREAS, By switching from its current costly cash-based payment system for school meals to a computerized Point of Sale (POS) system, SNS could generate an additional \$2.5 million annually to raise the nutrition value of the lunch and breakfast programs; and

WHEREAS, Savings would be generated by a decrease in administrative costs, as well as an increase in the number of students served; and,

WHEREAS, Improvements to the programs will have the largest effect on the 31,000 low-income students in the city as they represent the majority of students eating these meals and receive up to 80% of their nutrition for the day through these programs; and,

WHEREAS, The SFUSD does not have the budgetary authority to fund the POS system and is therefore seeking a grant from the Vitamin Cases Consumer Settlement Fund of \$999,589 over two years to purchase and implement the system; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors supports the SFUSD's efforts to purchase and implement a Point of Sale system to improve the Student Nutrition Services meal programs.
