[Urging Congress to Amend the Comprehensive Smoking Education Act of 1984]

Resolution urging U.S. Congressional Representatives to amend the Comprehensive Smoking Education Act of 1984 (Public Law 98-474) and require picture-based warning labels.

WHEREAS, In 2004, the Surgeon General reported a causal link between smoking and 28 individual diseases, including the leading causes of death in the Western world and harm to every major organ in the human body; and

WHEREAS, Public awareness about the severity of the health consequences of consuming tobacco products is significantly lower among working class and immigrant communities throughout the United States; and

WHEREAS, According to the 2000 United States Census nearly 1 in 5 people speak a language other than English at home, and 1 in 20 U.S. adults are not literate in English; and,

WHEREAS, A survey of 150 smokers in the San Francisco area conducted by POWER showed that, 97% of Spanish and Chinese speaking persons said they "did not know" or "could not understand" the meaning of the cigarette warning label when given a leaflet with all four Surgeon General Warnings; and

WHEREAS, Protection from language discrimination, particularly in regard to health care and access to health information, is an important component of the 1964 Civil Rights Act; and

WHEREAS, In 1998 the Office for Civil Rights of the Department of Health and Human Services issued a memorandum regarding the prohibition, under Title VI of the Civil Rights Act of 1964 against discrimination on the basis of national origin, including persons with limited English proficiency; and

WHEREAS, Health Canada and the Canadian federal health department introduced picture based warning labels in 1994; and

WHEREAS, In the first decade since picture based warning labels were introduced in Canada eight more countries have adopted similar legislation, while another fourteen countries are in various stages of consideration and implementation of similar requirements; and

WHEREAS recent research comparing smokers in Canada, the United States, the United Kingdom and Australia found that smokers in countries requiring large, graphic health warning labels on cigarette packs are more likely to recognize disease risks from smoking and to be motivated to quit smoking; and

WHEREAS, The recent report "Worth More Than A Thousand Words" released by POWER, the Data Center, and the San Francisco Tobacco Free Coalition recommends picture-based warning labels as a solution to language and literacy discrimination in tobacco health warning labels; and

WHEREAS, Congressional Representative Henry Waxman of Los Angeles has a long history of sponsoring legislation to strengthen the effectiveness of health warning labels on tobacco projects; and

WHEREAS Representative Waxman is now chair of the Congressional Committee on Oversight and Government Reform which has jurisdiction over federal policy on tobacco, including regulation of health warning labels; now, therefore, be it

RESOLVED, That San Francisco Board of Supervisors hereby urges U.S. Congressional Representatives who are concerned about tobacco control, language rights and civil rights to propose legislation to amend the Comprehensive Smoking Education Act of 1984 (Public Law 98-474) and require picture-based warning labels; and, be it FILE NO.

FURTHER RESOLVED, That the San Francisco Board of Supervisors hereby directs the Clerk of the Board to send a copy of this resolution to the San Francisco Congressional delegation and to Representative Henry Waxman, Chair of the Committee on Oversight and Government Reform, urging them to help initiate such amendments.
