3 **Resolution authorizing the Juvenile Probation Department to accept and expend a**
4 **grant in the amount of \$29,140 from the Corrections Standards Authority for enhanced**
5 **disproportionate minority contact technical assistance within the Juvenile Probation**

8 WHEREAS, The Correction Standards Authority has made funding available to support
9 enhanced Disproportionate Minority Contact Assistance for the Juvenile Probation
10 Department of the City and County of San Francisco; and

11 WHEREAS, Due to the Juvenile Probation Department’s need enhanced data capacity
12 to analyze disproportionality issues of youth in the San Francisco Juvenile Justice system;
13 and,

14 WHEREAS, The Juvenile Probation Department will use funds from the Correction
15 Standards Authority to address the system data gap between the Juvenile Probation
16 Department and the Courts and to enhance data capacity amount key systems to assist in
17 determining both short-term strategies as well as long-term strategies to reduce
18 Disproportionality;

19 WHEREAS, the Juvenile Probation Department has been selected to receive a, grant
20 in the amount of \$29,140 from the Correction Standards Authority;

21 WHEREAS, the grant does not require an ASO amendment; now, therefore be it

22 **RESOLVED**, That the Juvenile Probation Department of the City and County of San
23 Francisco is authorized to enter into the attached grant award agreement on behalf of the
24 City; and, be it

3 Francisco Juvenile Probation Department be authorized to accept and expend \$29,140 of the
4 grant funds for the benefit of the San Francisco Juvenile Probation Department; and, be it

6 requirements of the Correction Standards Authority and all conditions specified in the grant
7 agreement.


