3 **Resolution authorizing the Municipal Transportation Agency to accept and expend**  
4 **\$785,223 of federal Section 5309 Bus and Bus Facilities funding for design and**  
5 **construction of improvements to the Glen Park Intermodal Facility/Adjacent Areas.**

7 WHEREAS, The Secretary of Transportation is authorized to make monies available  
8 under the Safe, Accountable, Flexible, Efficient, Transportation Equity Act- A Legacy for Users  
9 (SAFETEA-LU); and

10 WHEREAS, The Municipal Transportation Agency (MTA), City and County of San  
11 Francisco, is an eligible claimant for Bus and Bus Facilities capital assistance under Section  
12 5309 of SAFTETEA -LU; and

13 WHEREAS, The grant contract for financial assistance will impose certain obligations  
14 on the applicant, including providing the local share of project costs; and

15 WHEREAS, The local share of project costs will be provided using City and County of  
16 San Francisco Planning Department funds; and

17 WHEREAS, The U.S. Department of Transportation (DOT) requires that in connection  
18 with the filing of an application for federal assistance, the applicant give an assurance that it  
19 will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of  
20 Transportation requirements implementing that Act; and

21 WHEREAS, It is the goal of the MTA that disadvantaged business enterprises (DBEs)  
22 be utilized to the fullest extent possible in connection with its federally funded projects, and  
23 that definitive procedures shall be established and administered, consistent with federal law,  
24 to ensure that DBEs shall have the maximum possible opportunity to compete for contracts,  
25 supplies, equipment contracts, or consultant and other services; and

1 WHEREAS, Congress has earmarked funding in SAFETEA-LU for a national program  
2 of projects using Section 5309 Bus and Bus Facilities capital assistance; and

3 WHEREAS, The Glen Park Intermodal Facility project, included in the national  
4 program, is a high priority San Francisco project; and

5 WHEREAS, The MTA Executive Director/CEO (or his designee) must execute  
6 agreements to complete transfer of the funds; and

7 WHEREAS, There is no allowance for indirect costs; and

8 WHEREAS, The grant does not require an ASO amendment now, therefore, be it


9 RESOLVED, That on behalf of the City and County of San Francisco, the MTA is  
10 authorized to accept and expend \$785,223 of Section 5309 Bus and Bus Facilities capital  
11 assistance for the design and construction of improvements to the Glen Park Intermodal  
12 Facility/Adjacent Areas; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors waives inclusion of indirect  
14 costs in the grant budget; and, be it


15 FURTHER RESOLVED, That the MTA is authorized to furnish whatever additional


