3 **Resolution approving the Professional Services Agreement for the Management and**  
4 **Operation of the Airport's Public and Employee Parking Facilities between New South**  
5 **Parking - California and the City and County of San Francisco, acting by and through**  
6 **its Airport Commission.**

8 WHEREAS, The Airport Commission authorized the issuance of a Request for  
9 Proposals for the Management and Operation of the Airport's Public and Employee Parking  
10 Facilities; and,

11 WHEREAS, A five-member panel reviewed and rated the qualifying proposals and oral  
12 presentations in accordance with the Commission-approved selection criteria; and

13 WHEREAS, New South Parking – California was deemed the highest rated proposer;  
14 and,

15 WHEREAS, Staff negotiated the final terms of the Professional Services Agreement for  
16 the Management and Operation of the Airport's Public and Employee Parking Facilities with  
17 New South Parking – California; and,

18 WHEREAS, On January 16, 2007, pursuant to Resolution 07-0003, the Airport  
19 Commission awarded the Professional Services Agreement to New South Parking – California  
20 for a term of three years, commencing July 1, 2007, in a total amount not to exceed  
21 \$48,287,442, with two one-year options exercisable at the sole discretion of the Airport  
22 Commission; now, therefore, be it

23 RESOLVED, That the Board of Supervisors hereby approves the Professional Services  
24 Agreement for the Management and Operation of the Airport's Public and Employee Parking  
25 Facilities between New South Parking - California and the City and County of San Francisco,

1 acting by and through its Airport Commission, for a three-year term, in a total amount not to  
2 exceed \$48,287,442, with two one-year options exercisable at the sole discretion of the  
3 Airport Commission, copies of which are contained in Board of Supervisors' File Number  
4 070227.
