Resolution approving the City and County of San Francisco 2007 grant application for the United States Department of Housing and Urban Development Continuum of Care Programs and fulfilling the San Francisco Board of Supervisors review and approval process for all annual or otherwise recurring grants of \$5,000,000 or more.

WHEREAS, Under the Department of Housing and Urban Development 2007 grant application for Continuum of Care Programs, the City and County of San Francisco and eligible nonprofit entities are eligible to submit funding applications to assist the homeless; and

WHEREAS, Under the San Francisco 2006 Continuum of Care application, San Francisco and its nonprofits were awarded \$18,910,893 based on very strong and completive grant application; and

WHEREAS, HUD, is expected to announce soon its 2007 Continuum of Care program requirements and guidelines, including an anticipated May 29, 2007 deadline for submittal of grant applications; and

WHEREAS, The San Francisco Local Homeless Coordinating Board (LHCB) serves as the legal entity that oversees the Continuum of Care process and programs, including the creation of program priorities, funding categories, and application guidelines; and

WHEREAS, THE LHCB expects to submit a consolidated application for at least \$18,000,000, of which the portion of those which passes through the Department of Human Services is greater than \$5,000,000; and

WHERAS, The LHCB has been meeting regularly to better understand the Continuum of Care process and programs, including receiving community input and participation in the development of program priorities and categories and as well as application guidelines and process; and

WHEREAS, on January 8, 2007 and February 5, 2007, the LHCB with community input and advice, approved a 2007 application process to allow all eligible applicants sufficient time to complete competitive grant applications that will be evaluated and ranked by the LHCB for submittal as part of a comprehensive grant application prior to the anticipated May 29, 2007 deadline;

WHREAS, the 2007 application process established funding categories that include Permanent Supportive Housing, Transitional Housing, Safe Haven, Supportive Services and the Shelter Plus Care Program; and

WHEREAS, Under San Francisco Ordinance 265-05, the appropriate City department shall submit a resolution articulating its grant application as well as funding categories to the Board of Supervisors for all annual grant applications of \$5,000,000 or more; now, therefore, be it

RESOLVED, That San Francisco Local Homeless Coordinating Board and the Department of Human Services are authorized to submit a 2007 Continuum of Care application; and, be it

FURTHER RESOLVED, That San Francisco Board of Supervisors will provide for a timely review and approval of the 2007 Continuum of Care application with recognition that such application at the time of Board review and approval will include funding categories and general description of the application.
