

1 [Apply For-Accept-Expend Federal Funding – Community Development Block Grant.]

3 **Resolution approving the 2007/08 Community Development Block Grant (CDBG)**  
4 **Program; authorizing the Mayor, on behalf of the City and County of San Francisco, to**  
5 **apply for, accept, and expend the City's 2007/08 Community Development Block Grant**  
6 **Program entitlement from the U.S. Department of Housing and Urban Development**  
7 **(HUD) together with Program Income and Reprogrammed Funds, totaling \$24,618,026.**

9 WHEREAS, Under Title I of the Housing and Community Development Act of 1974, as  
10 amended, and related Federal Regulations, the City and County of San Francisco is eligible to  
11 apply for and receive a Community Development Block Grant (CDBG); and,

12 WHEREAS, The City and County of San Francisco anticipates receiving approximately  
13 \$21,930,509 in 2007/08 CDBG Program funds from HUD, approximately \$407,517 in  
14 reprogrammed funds from prior year CDBG Programs and approximately \$2,280,000 in  
15 2007/08 program income from previous CDBG grants, for a combined total of approximately  
16 \$24,618,026; and,

17 WHEREAS, The Board of Supervisors, by Resolution 288-04 placed \$360,000 on  
18 reserve for Mission Housing Development Corporation, and by Resolution 295-05 placed  
19 \$17,517 on reserve for planning, salary and overhead expenses in the Mayor's Office of  
20 Housing; and,

21 WHEREAS, The Citizen's Committee on Community Development (CCCD) has  
22 reviewed applications and prepared recommendations for fiscal year 2007/2008 CDBG and  
23 program income funding as set forth in a recommended Expenditure Schedule, a copy of  
24 which is located in Board File No. 070397; and,

25 WHEREAS, The grant does not require an ASO amendment; and,

1           WHEREAS, The funding agency does not allow use of grant on indirect costs; and,  
2           WHEREAS, An Environmental Review Record has been prepared by the Mayor's  
3 Office of Community Development (MOCD) and approved by the Certifying Officer for the  
4 proposed projects and activities set forth in the Expenditure Schedule with the National  
5 Environmental Policy Act (NEPA) and other applicable statutes and authorities, in particular  
6 those cited in 24 CFR Part 58 §§5 and 6, a copy of which is located in Board File No.  
7 070397 ; and,

8           WHEREAS, The Certifying Officer shall follow the provisions of NEPA to confirm and  
9 ensure that all projects funded under the CDBG Program are in compliance with applicable  
10 federal regulations and requirements; now, therefore, be it

11           RESOLVED, That the Mayor of the City and County of San Francisco is hereby  
12 authorized to apply for, accept, and expend the City's 2007 CDBG entitlement from HUD,  
13 expend an estimated \$407,517 in reprogrammed CDBG funds, including \$377,517 of funds  
14 released from reserve, and to accept and expend an estimated \$2,280,000 in program income  
15 generated by MOCD, the Mayor's Office of Housing and the San Francisco Redevelopment  
16 Agency, all in accordance with the purposes and goals for the funding as generally set forth in  
17 CDBG 2005-09 Five Year Consolidated Plan and the Expenditure Schedule; and, be it

18           FURTHER RESOLVED, That the Board of Supervisors does hereby approve the  
19 purposes and goals for 2007/08 CDBG Program funding as set forth in the Expenditure  
20 Schedule for recipient agencies and departments; and, be it


21           FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
22 indirect costs in the grant budget; and, be it

1 FURTHER RESOLVED, That the Mayor is hereby authorized to enter into and execute  
2 agreements between the City and County of San Francisco and various agencies consistent  
3 with the 2007/08 CDBG Program; and, be it


4 FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation  
5 and certifications as may be requested or required by HUD, and to take such additional  
6 actions as may be required to apply for, accept and expend the 2007/08 CDBG funds and the  
7 reprogrammed funds consistent with this Resolution and the goals of the 2007/08 CDBG  
8 Program; and, be it

9 FURTHER RESOLVED, That all actions heretofore taken by the officers of the City  
10 with respect to the application for, or the acceptance or expenditure of, 2007/08 CDBG funds,  
11 reprogrammed funds and program income are hereby approved, confirmed and ratified.


