

1 [Grant for California Pandemic Influenza Preparedness funds.]

3 Resolution authorizing the San Francisco Department of Public Health (DPH),
4 Communicable Disease Control and Prevention Section to accept and expend
5 retroactively a new grant in the amount of \$133,662, from the Centers for Disease
6 Control and Prevention (CDC) and the California Department of Health Services
7 (CDHS), to fund pandemic influenza emergency preparedness activities and to enter
8 into an agreement with the CDHS for the use of these funds; for the period of August
9 31, 2006 through August 30, 2007.

11 WHEREAS, DPH, Communicable Disease and Prevention Section has been awarded
12 a new grant from the CDHS/CDC in the amount of \$133,662 to support pandemic influenza
13 activities in San Francisco, specifically intended to develop and exercise pandemic influenza
14 plans for the period of August 31, 2006 through August 30, 2007; and,

15 WHEREAS, The objectives of this project include a) prepare for special populations; b)
16 increase surveillance; c) plan for non-pharmacological interventions; d) implement and
17 maintain isolation and quarantine; e) increase providers on California Health Alert Network; f)
18 increase coordination with hospitals and clinics; g) test through drills and exercises; and,

19 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to
20 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
21 Board of Supervisors in File No. 070307; which is hereby declared to be a part of
22 this resolution as if set forth fully herein; and,

23 WHEREAS, the grant does not require an ASO amendment and reimburses the
24 department for two existing positions, a Senior Health Program Planner position (Job Class
25

1 2820) from April 1, 2007 through May 31, 2007 and a Nurse Manager (Job Class 2322) at
2 1.00 FTE from March 1, 2007 through August 30, 2007; and,

3 WHEREAS, The grant budget includes a provision for indirect costs of \$9,650; now,
4 therefore, be it


5 RESOLVED, That DPH, Communicable Disease and Prevention Section, is hereby
6 authorized to accept and expend retroactively a grant in the amount of \$133,662 from the
7 CDHS/CDC; and, be it

8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
9 expend the grant funds in accordance with the requirements set forth in the Agreement,
10 pursuant to San Francisco Administrative Code section 10.170-1; and, be it

11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
12 agreement on behalf of the City; and, be it

13 FURTHER RESOLVED, That the Controller is directed to designate all positions
14 funded under this agreement as "G" or grant-funded positions which would terminate when
15 the agreement expires.




