3 **Resolution Approving Rules and Regulations for the Nonprofit Performing Arts Loan**
4 **Program.**

5 WHEREAS, The Nonprofit Performing Arts Loan Program (NPALP) was established by
6 the Board of Supervisors in 1984 to help facilitate capital acquisition and improvements to
7 several small to midsize theaters and performance spaces in San Francisco; and

8 WHEREAS, In May of 2006, under Ordinance No. 114-06, the Board of Supervisors
9 transferred administration of the NPALP program from the Mayor's Office of Housing to the
10 Grants for the Arts program; and

11 WHEREAS, Section 50.11 of the Administrative Code requires that the Director of the
12 Grants for the Arts Program "promulgate such rules and regulations as he or she may deem
13 appropriate to carry out" the provisions of the Nonprofit Performing Arts Loan Program,
14 "including rules and regulations for general payment schedule adjustments, individualized
15 payment schedule adjustments and criteria for loan forgiveness..."; and

16 WHEREAS, Section 50.11 of the Administrative Code requires that such rules and
17 regulations "be developed in consultation with pertinent City and County agencies and any
18 other appropriate organizations which the Director in his or her discretion may choose to
19 consult" and that the "Board of Supervisors shall by resolution approve all such rules and
20 regulations" prior to their effective date; and

21 WHEREAS, the Director has developed such proposed regulations in accordance with
22 the requirements of the Administrative Code; now, therefore, be it

23 RESOLVED, That the Board of Supervisors hereby approves the Director's proposed
24 regulations, dated as of November 14, 2006 (as amended on April 19, 2007), a copy of which
25 is on file with the Clerk of the Board of Supervisors.
