3 **Resolution appointing Nancy Lim-Yee, Suzanne Giraud, and Dr. Shannon Thyne,**  
4 **terms ending April 29, 2011, to the Children and Families First Commission; residency**  
5 **requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby appoint the hereinafter designated persons to serve as members of the Children  
9 and Families First Commission, pursuant to the provisions of the San Francisco  
10 Administrative Code, Sections 10.117-122 and 86.1 through 86.5, for the terms specified:

11 Nancy Lim-Yee (residency requirement waived), succeeding Raymond Weisberg, term  
12 expired, seat 6, must represent one or more of the following: children services, public health  
13 services; behavioral health services, social services and tobacco and other substance abuse  
14 prevention and treatment services; recipients of project services included in the county  
15 strategic plan; educators specializing in early childhood development; representatives of a  
16 local child care resource or referral agency, the Child Care Planning and Advisory Council or  
17 another local child care coordinating group; representatives of a local organization for  
18 prevention or early intervention for families at risk; representatives of community-based  
19 organizations that have the goal of promoting and nurturing early childhood development;  
20 representatives of local school districts; and representatives of local medical, pediatric, or  
21 obstetric associations or societies; for a four-year term ending April 29, 2011.

22 Suzanne Giraud, succeeding Cheryl Polk, term expired, seat 7, must represent one or  
23 more of the following: children services, public health services; behavioral health services,  
24 social services and tobacco and other substance abuse prevention and treatment services;  
25 recipients of project services included in the county strategic plan; educators specializing in

1 early childhood development; representatives of a local child care resource or referral agency,  
2 the Child Care Planning and Advisory Council or another local child care coordinating group;  
3 representatives of a local organization for prevention or early intervention for families at risk;  
4 representatives of community-based organizations that have the goal of promoting and  
5 nurturing early childhood development; representatives of local school districts; and  
6 representatives of local medical, pediatric, or obstetric associations or societies; for a four-  
7 year term ending April 29, 2011.

8 Dr. Shannon Thyne, succeeding Lucy Crain, term expired, seat 9, must represent one  
9 or more of the following: children services, public health services; behavioral health services,  
10 social services and tobacco and other substance abuse prevention and treatment services;  
11 recipients of project services included in the county strategic plan; educators specializing in  
12 early childhood development; representatives of a local child care resource or referral agency,  
13 the Child Care Planning and Advisory Council or another local child care coordinating group;  
14 representatives of a local organization for prevention or early intervention for families at risk;  
15 representatives of community-based organizations that have the goal of promoting and  
16 nurturing early childhood development; representatives of local school districts; and  
17 representatives of local medical, pediatric, or obstetric associations or societies; for a four-  
18 year term ending April 29, 2011; and, be it

19 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 20 1. The membership of the Children and Families First Commission has a goal to be  
21 representative of the diversity of the City and County of San Francisco.
- 22 2. Applicant Nancy Lim-Yee, a new appointee, who is not a resident of San Francisco,  
23 is a person with experience that uniquely qualifies her to serve on the Children and  
24 Families First Commission.

1 3. The Children and Families First Commission has attempted to fill the position, for  
2 which Nancy Lim-Yee was nominated, with an individual who is a City resident and  
3 who has the specific experience, skills, and qualifications, but has been unable to  
4 do so at this time. The Rules Committee has certified that Nancy Lim-Yee is  
5 qualified to serve on the Children and Families First Commission.

6 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
7 other possible representative, who is a resident of San Francisco and who has the  
8 specific experience, skills, or qualifications possessed by this applicant, and who is  
9 willing to serve on the Children and Families First Commission at this time; and, be  
10 it

11 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
12 requirement for Nancy Lim-Yee, as allowed in cases where no qualified City resident, willing  
13 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
14 appointed to boards, commissions, and advisory bodies established by legislative act of the  
15 Board of Supervisors to be resident(s) of the City and County of San Francisco.


