5 RESOLVED, That, in accordance with the provisions of the California Vehicle code and  
6 the San Francisco Traffic Code, the following regulations governing the parking of vehicles  
7 are hereby enacted or rescinded as designated below:

8 **NO PARKING ANYTIME – ESTABLISH**

9 Eucalyptus Drive, south side, from the Junipero Serra Boulevard Service Road  
10 to 33 feet westerly.

11 **TOW-AWAY, NO PARKING ANYTIME – ESTABLISH**

12 Vicente Street, south side, from Portola Drive to 49 feet westerly, (approved for  
13 a 60 day trial; further approval subject to review and approval of a report by the Department of  
14 Parking and Traffic).

16 Categorically exempt from Environmental  
17 Review Class 1©(9) changes in the traffic and  
18 parking regulations where such changes do not  
19 establish a higher speed limit or result in more  
20 than a negligible increase in the use of the  
21 street.


