

1 [Accept-Expend Federal Grant—2007 Mayor's Summer Food Service Program and
2 Afterschool Snack program}

3 **Resolution authorizing the San Francisco Department of Children, Youth and their**
4 **Families (DCYF), to accept and expend a grant in the amount of \$876,988, currently and**
5 **retroactively, from the United States Department of Agriculture for the 2007 Mayor's**
6 **Summer Food Service Program and the After School Snack Program.**

8 WHEREAS, The United States Department of Agriculture provides funds to the City
9 and County of San Francisco to operate the Summer Food Service Program; and,

10 WHEREAS, The funding will provide children 0-18 with free lunches during the
11 summer months from June to August 2007; and,

12 WHEREAS, An average of 5,000 children will be served lunch each day during the
13 summer at approximately 110 sites throughout the City; and

14 WHEREAS, The United States Department of Agriculture has created a pilot Year-
15 Round Feeding program to provide reimbursement funding for sponsors to provide After
16 School snacks for children; and,

17 WHEREAS, Funding from the Year-Round Feeding Program will enable the City and
18 County of San Francisco's After School Snack Program to provide children with free snacks
19 through 50 After School program sites, providing an average of 1500 children per day with a
20 nutritious snack during After School hours; and


21 WHEREAS, the grant terms prohibit indirect costs; now, therefore be it

22 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
23 the grant budget; and be it



24 FURTHER RESOLVED, That the City and County of San Francisco hereby authorizes the
25 Department of Children, Youth and Their Families to apply for, accept and expend funds in

1 the amount of \$876,988, currently and retroactively, from the United States Department of
2 Agriculture to sponsor the 2007 Mayor's Summer Food Service program and After School
3 Snack Program.




