4 **Resolution directing the San Francisco Public Utilities Commission to create and**  
5 **implement a city-wide program to track water usage, water conservation, and recycled**  
6 **water use by City Departments.**

8 WHEREAS, Water conservation requires the participation of all water users, including  
9 City Departments; and

10 WHEREAS, On June 11, the Public Utilities Commission passed a resolution to create  
11 a working group whose mission will be to develop recommendations that the San Francisco  
12 Public Utilities Commission will advocate for passage at the Board of Supervisors, including  
13 conservation programs for all rate paying customers, including but not limited to commercial  
14 users and City Departments; and,

15 WHEREAS, City Departments, particularly the Recreation and Park Department and  
16 the Department of Public Works, use large quantities of water; and,

17 WHEREAS, tracking water use is a necessary first step to understand how City  
18 Departments can best conserve water; and

19 WHEREAS, The City lacks a city-wide program to track water usage, water  
20 conservation, and recycled water use by City Department; now, therefore, be it

21 **RESOLVED**, That the Board of Supervisors directs the San Francisco Public Utilities  
22 Commission to create and implement a city-wide program to track water usage, water  
23 conservation, and recycled water use by City Departments by December 1, 2007; and, be it

1           FURTHER RESOLVED, That the Board of Supervisors directs the San Francisco  
2 Public Utilities Commission to report back to the Board of Supervisors by December 1, 2007  
3 regarding the details of the city-wide program to track water usage, water conservation, and  
4 recycled water use by City Departments; and be it

5           FURTHER RESOLVED that the Board of Supervisors directs the San Francisco Public  
6 Utilities Commission to report back to the Board of Supervisors by August 1, 2008 regarding  
7 the amount of water savings achieved by the city-wide program to track water usage, water  
8 conservation, and recycled water use by City Department.
