Resolution authorizing the San Francisco Department of Public Health (DPH) to retroactively accept and expend a grant in the amount of \$287,177 from the California Department of Alcohol and Drug Programs (DADP) to plan and implement a dependency drug court that works across city departments; for the period of July 1, 2007 to December 31, 2007.

WHEREAS, DADP increased by \$287,177 and extended the timeline for six months of an existing grant to establish and maintain a drug court in SF Dependency Court; and,

WHEREAS, This is a joint project of DPH, the Superior Court of San Francisco and the Child Welfare Service of the San Francisco Human Services Agency; and,

WHEREAS, DADP requires that the funds be administered by the San Francisco County Alcohol and Drug Program Administrator, which is located within DPH; and,

WHEREAS, The entire amount will be used to award contracts on the basis of recent RFPs Family and Perinatal Substance Abuse Treatment, and a sole source contract with Superior Court for a Dependency Drug Court Coordinator and related new court costs; and,

WHEREAS, DPH anticipates \$287,177 to also be awarded in future years on the calendar year to maintain the program; and

WHEREAS, As a condition of receiving the grant funds, DADP requires the City to comply with the terms of an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. <u>071297</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The grant does not require an ASO amendment because staffing costs are not included in the budget; and,

WHEREAS, The Department proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That SFDPH is hereby authorized to retroactively accept and expend a grant in the amount of \$287,177 from DADP; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget, and, be it

FURTHER RESOLVED, That SFDPH is hereby authorized to accept retroactively and expend the grant funds in accordance with the requirements set forth in the Agreement, pursuant to San Francisco Administrative Code Section 10.170-1.
