

1 [Proposition J: Contracting Out Transit Shelter Advertising and Maintenance Services]

3 **Resolution concurring with the Controller's determination that it is more economical**  
4 **for the San Francisco Municipal Transportation Agency to contract for transit shelter**  
5 **advertising and maintenance services than to provide the same services with City**  
6 **employees for Fiscal Year 2007-08.**

8 WHEREAS, Transit shelter advertising and maintenance services have been  
9 contracted out since their inception in 1987; and

10 WHEREAS, On September 4, 2007, the Municipal Transportation Agency Board of  
11 Directors adopted Resolution No. 07-149, which authorized the SFMTA to enter into a new  
12 Transit Shelter Advertising Agreement with Clear Channel Outdoor, Inc. ("Clear Channel"),  
13 commencing on December 10, 2007; and,

14 WHEREAS, The Controller's Office has determined that such services can be  
15 practically performed under private contract at a lesser cost than similar work performed by  
16 City employees, which determination, dated September 14, 2007, is on file with the Clerk of  
17 the Board of Supervisors in File No. 071365; and,

18 WHEREAS, Section 10.104(15) of the San Francisco Charter ("Prop. J") allows the  
19 SFMTA to contract for services when the Controller has determined that such services can be  
20 practically performed under private contract at a lesser cost than similar work performed by  
21 City employees and the Board of Supervisors annually approves contracting out for such  
22 services; and

23 WHEREAS, On October 2, 2007, the MTA Board of Directors approved Resolution No.  
24 \_\_\_\_\_, in which the MTA Board recommended that the Board of Supervisors concur  
25 with the Controller's determination that it is more economical for the SFMTA to contract for

1 transit shelter advertising and maintenance services than to provide the same services with  
2 City employees for Fiscal Year 2007-08; and

3 WHEREAS, The Controller performed an analysis of the entire scope of services  
4 to be performed for the Fiscal Year 2007-08 Prop. J analysis, but has concluded that for future  
5 years, only the ongoing maintenance services provided under this contract will require annual  
6 Prop. J analysis; now, therefore, be it

7 RESOLVED, That the Board of Supervisors concurs with the Controller's determination  
8 that transit shelter advertising and maintenance services can be practically performed by a  
9 private contractor at a lower cost than by City and County employees for Fiscal Year 2007-08.


