[Grant of Federal Funds.]

Resolution authorizing the Municipal Transportation Agency to accept and expend \$31,854,482 of Federal Transit Administration Section 5307 capital assistance for various Municipal Railway capital projects and activities, excluding citywide indirect costs.

WHEREAS, The Secretary of Transportation is authorized to make monies available under the Federal Safe, Accountable, Flexible, Efficient, Transportation Equity Act-A Legacy for Users (SAFETEA-LU) for mass transportation projects; and

WHEREAS, The Municipal Transportation Agency (MTA), City and County of San Francisco, is an eligible claimant for flexible capital or operating assistance projects under Section 5307 of SAFETEA-LU; and

WHEREAS, Section 5307 is a formula-apportioned resource that may be used for any eligible planning or capital purpose; and

WHEREAS, The grant contract for financial assistance will impose certain obligations upon the applicant, including providing the local share of project costs; and

WHEREAS, The local share of project costs will be funded through a variety of sources, which may include San Francisco Municipal Railway Fare Revenue, San Francisco Municipal Railway Improvement Corporation funds, Regional Bridge Toll net revenues, and/or sales taxes administered by the San Francisco County Transportation Authority; and

WHEREAS, The U.S. Department of Transportation (DOT) requires that in connection with the filing of an application for federal assistance, the applicant give an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements implementing that Act; and

Supervisor Peskin BOARD OF SUPERVISORS WHEREAS, It is the goal of the applicant that disadvantaged business enterprises (DBEs) be utilized to the fullest extent possible in connection with this project, and that definitive procedures shall be established and administered, consistent with federal law, to ensure that DBEs be utilized to the fullest extent possible and shall have the maximum possible opportunity to compete for contracts, supplies, equipment contracts, or consultant and other services; and

WHEREAS, The Metropolitan Transportation Commission has prepared a regional program of projects that are funded through Section 5307; and

WHEREAS, The Municipal Railway's projects that are included in the regional program are high priority Municipal Railway capital improvements listed in the current MTA Short Range Transit Plan and in the Regional Transportation Plan; and

WHEREAS, The grant does not require an ASO amendment; and WHEREAS, There is no allowance for citywide indirect costs; now, therefore, be it RESOLVED, That, on behalf of the City and County of San Francisco, the MTA is authorized to accept and expend \$31,854,482 in federal Section 5307 capital assistance for the following projects:

- Historic Rail Car Rehab/Rebuild
- Metro East Facility Construction
- Escalator Rehab/Rebuild
- Flynn Facility Ventilation system Rehab/Replacement
- Paratransit Assistance
- Security Equipment Procurement
- Safety Modifications
- Fall Protection System
- Woods Facility Lift Replacement; and, be it
