3 **Resolution supporting Fiscal Year 2008-2009 Community Development Block Grant**
4 **(CDBG) Action Plan Goals.**

6 WHEREAS, Under Title I of the Housing and Community Development Act of 1974, as
7 amended, and related federal regulations, the City and County of San Francisco is eligible to
8 apply for and receive Community Development Block Grant (CDBG) funding from the U.S.
9 Department of Housing and Urban Development (HUD); and

10 WHEREAS, The City and County of San Francisco anticipates receiving approximately
11 \$21,500,000 in CDBG Program Funds from HUD in 2008-09; and,

12 WHEREAS, On behalf of the City and County of San Francisco, the Mayor's Office of
13 Community Development (MOCD) is preparing to release a Request for Proposals (RFP) for
14 the 2008-09 CDBG Program; and,

15 WHEREAS, the RFP is in concert with the MOCD Consolidated Plan for program years
16 2005-2009; and,


17 WHEREAS, the Consolidated Plan was approved by HUD in 2005; and,

18 WHEREAS, the Consolidated Plan details MOCD's and the Mayor's Office of Housing's
19 (MOH) seven goals for the CDBG Program: 1) Promote economic self-sufficiency for low and
20 moderate income families; 2) Strengthen neighborhood vitality; 3) Increase the provision of
21 timely, relevant and effective social services; 4) Promote equity-based public policy strategies;
22 5) Create housing opportunities for the homeless; 6) Create affordable rental housing for
23 individuals and families with incomes up to 60% of San Francisco median income; and 7)
24 Create homeownership opportunities for individuals and families up to 100% of San Francisco
25 median income, and support existing homeownership programs including funding housing

1 counseling agencies to advise eligible San Franciscans of existing homeownership programs,
2 for families up to 120% of median income; now, therefore, be it

3 RESOLVED, That the Board of Supervisors continues to support the seven 2005-2009
4 CDBG Consolidated Plan goals, and the related 2008-2009 Request for Proposals to achieve
5 these goals.


