Resolution approving the expenditure of one-hundred thirty-seven thousand, sevenhundred and twenty-eight dollars (\$137,728.00) of Community Development Block Grant funding.

WHEREAS, Each year the City and County of San Francisco receives Community Development Block Grant ("CDBG") funding under Title I of the Housing and Community Development Act of 1974, as amended; and,

WHEREAS, The Mayor's Office of Community Development ("MOCD") prepared proposals for the acceptance and expenditure of CDBG funds for fiscal years 2005-2007, and the Board of Supervisors approved the acceptance and expenditure of such funds in accordance with the MOCD proposals by Resolution Nos. 294-05; 277-06 and 197-07 (the "Authorizing Resolutions"); and,

WHEREAS, MOCD has closed out grants made pursuant to the Authorizing Resolutions, and as a result MOCD has recaptured CDBG funds in an amount equal to onehundred thirty-seven thousand, seven-hundred and twenty-eight dollars (\$137,728.00); and,

WHEREAS, MOCD has reprogrammed the Recaptured Funds as set forth in the CDBG Summary, a copy of which is located in Board File No. 071402 (the "Reprogram Summary"); and,

WHEREAS, MOCD's Certifying Officer shall follow the procedural provisions of NEPA to make certain that all projects and reprogrammed dollars under the Revised Funding Program are performed and spent in compliance with the applicable federal provisions and requirements; now, therefore, be it

Supervisor Maxwell BOARD OF SUPERVISORS RESOLVED, That the Board of Supervisors hereby approves the reprogramming of the Recaptured Funds in accordance with the Reprogram Summary; and, be it

FURTHER RESOLVED, That MOCD is hereby authorized to enter into such agreements and take such actions as are consistent with this resolution; and, be it

FURTHER RESOLVED, That MOCD is hereby authorized to submit such documentation and certifications as may be required by the U.S. Department of Housing and Urban Development to effectuate the above reprogramming of CDBG dollars.
