WHEREAS, The grant does not require an ASO amendment and partially reimburses the department for an existing position, Health Program Coordinator III (Job Class #2593) at .05 FTE for the period of November 5, 2007 through April 30, 2008; and,

WHEREAS, A request for retroactive approval is being sought because the final agreement was not obtained by DPH until November 13, 2007; and,

WHEREAS, The budget includes provision for indirect costs of \$1,010; now therefore, be it
